YOUTH SOCCER ACADEMY: WITH HAITIAN GOVERNMENT COVID MANDATES RESTRICTING PROGRAMS IN THE SPRING AND SUMMER OF 2020, THE PLH SOCCER PROGRAM HAD TO TAKE AN UNEXPECTED BREAK. PRACTICES RESTARTED LATE SUMMER, AND IN NOVEMBER, WE LAUNCHED THE PLH SOCCER ACADEMY. THIS NEW STRUCTURE ALLOWED FOR MORE DISCIPLESHIP, MORE FOCUSED ATTENTION AND TRAINING, AND HAND-PICKED, CONTRACTED COACHES. THE YOUTH OF HAITI HAVE FEW OPTIONS FOR SAFE PLAY AND FEW OPPORTUNITIES TO GROW AND LEARN WITHIN POSITIVE ENVIRONMENTS. AT THE SAME TIME, THEY FACE MANY TEMPTATIONS TO TURN TO UNHEALTHY OR CRIMINAL LIFESTYLES. THE PLH SOCCER PROGRAM AND ACADEMY PROVIDES KIDS WITH A SAFE PLACE TO PLAY, A COACHING STAFF THAT CARES ABOUT THEM, AND AN OPPORTUNITY TO GROW IN BOTH THEIR SPORT AND THEIR LIFE. CONTINUED IN SCHEDULE O.

ENGLISH INSTITUTE: THE PLH ENGLISH INSTITUTE REOPENED ITS CLASSES IN JANUARY OF 2020 AFTER HAVING TO CLOSE DUE TO CIVIL UNREST THROUGHOUT HAITI IN THE FALL OF 2019. UNFORTUNATELY, CLASSES HAD TO CLOSE YET AGAIN IN MARCH OF 2020 WHEN COVID RESTRICTIONS WERE PUT IN PLACE. RESTRICTIONS WERE LIFTED AND CLASSES RESUMED IN SEPTEMBER OF 2020. DURING 2020, THE PLH ENGLISH INSTITUTE CONSISTED OF SIX CLASSES RANGING IN FOUR LEVELS AND SERVED 90 STUDENTS. IN JANUARY OF 2021, WE ADDED TWO NEW BASIC-LEVEL CLASSES AND OFFERED SPECIALIZED COURSES FOR THE HIGHEST LEVEL STUDENTS, THOSE COURSES BEING MEDICAL ENGLISH AND TEACHING ENGLISH AS A FOREIGN LANGUAGE. WITH THESE NEW COURSES, WE NOW HAVE NEARLY 150 STUDENTS. CONTINUED IN SCHEDULE O.

EMPLOYMENT AND JOB SKILLS TRAINING: CONSTRUCTION PROJECTS IN 2020 CONSISTED OF POURING FOUNDATIONS; INSTALLING LARGE DRAINAGE PIPES FOR THE SOCCER FIELDS; AND CONSTRUCTING A 4-BEDROOM GUESTHOUSE; A LARGE, COVERED WORKSHOP; A PREFABRICATED, MULTI-PURPOSE BUILDING; AND CONCRETE AS WELL AS DIRT CANALS TO DIVERT RAIN WATER. WITH EACH PROJECT, PLH HIRED LOCAL MASONS, HEAVY EQUIPMENT OPERATORS, AND LABORERS TO CARRY OUT THE WORK WITH SUPERVISION AND OVERSIGHT FROM SKILLED PROFESSIONALS FROM OREGON WHO VOLUNTEERED THEIR TIME AND KNOWLEDGE TO CONTRIBUTE TO THE PROJECTS IN HAITI. THE HAITIAN WORKERS WERE ABLE TO LEARN AND GROW AS THEY WORKED ALONGSIDE THE HIGHLY-EXPERIENCED VISITORS. THIS COLLABORATION AND WILLINGNESS TO WORK TOGETHER AND LEARN FROM ONE ANOTHER IS CENTRAL TO PLH. CONTINUED IN SCHEDULE O.
